A black male driver was stopped on February 4, 2022 for driving a vehicle with excessive tint. The rear window tint registered 12% when the minimum tint is 35%. The white male deputy also requested a free air sniff by a K9 because the same driver was arrested in March of 2021 with 2022-02-10 two pounds of marijuana in the same vehicle. The K9 did alert to the vehicle. There was no illegal contraband found in the vehicle after a search was conducted and he received a warning for excessive tint. The driver felt he was stopped and his vehicle was searched due to the color of his skin.

The traffic stop was lawfully based upon probable cause for a traffic infraction. The vehicle search was conducted upon probable cause from the positive alert of the K9. The complaint was investigated and there was no evidence to support racial profiling. The complaint was Exonerated.
